## A Property Insurance Value Waiver Request was granted in 2015.

This waiver, which is still in effect, allows the Agreed Upon Value of our School/Convent to remain \$750,000. Our insurance payments per quarter have been reduced from \$3,607.34 to \$683.63. The *quarterly* savings in property insurance for the School/Convent are \$2,923.71.

The Agreed Upon Value of the Rectory/Garage remains \$400,000. Our insurance payments per quarter have been reduced from \$657.33 to \$364.60. The *quarterly* savings in property insurance for the Rectory/Garage are \$292.73.

The total savings per quarter for the School/Convent & Rectory/Garage are \$3,216.44. This amount multiplied by 4 quarters per year = \$12,865.76. These savings are based upon the Agreed Upon Value of the buildings.

The value of the church is the Full Replacement Value of the building which remains \$4,646,074.
